SE 1/4 Sec. 5 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 10 FEET IN AN/AN EAST DIRECTION, AND, 1490  
FEET IN A/AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE

ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY NRS. 517.030.
