THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 670' N40E FROM SW CRW SW 1/4 Sec. 4, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 Sec. 4, SE 1/4 Sec. 5 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/AN EAST DIRECTION, AND, 1490 FEET IN A/AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
