NW 1/4 Sec. 9 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 1490 FEET IN AN/AN EAST DIRECTION, AND, 10  
FEET IN A/AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
