SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 9 NE 1/4 Sec. 8 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/AN EAST DIRECTION, AND, 1490 FEET IN A/AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
