SE 1/4 SW 8 T15N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490
FEET IN A/West DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
