THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 630' N55E FROM SW CRW SW 14 Sec. 9, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SU 14 Sec. 9 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN/AN EAST DIRECTION, AND, 10 FEET IN A/AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
