MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec 16, NE 1/4 Sec 17,
UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490
FEET IN A/West DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
