SAID CLAIM LIES WITHIN THE N 1/4 Sec 16 FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
