THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 750' N35E FROM SW 1/4 Sec. 16, TOWNSHIP 19N, RANGE 53E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE N 1/4 Sec. 16 M.D.M. FROM THIS DISCOVERY MONUMENT, THE

UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
