SAID CLAIM LIES WITHIN THE SW 1/4, FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/WEST DIRECTION, AND, 1490 FEET IN A/N EAST DIRECTION, AND, 48 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 96 FEET WIDE AND 1500 FEET LONG.
