MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE S 1/4 Sec 16,
UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490
FEET IN A/West DIRECTION, AND, 48 FEET ON EACH SIDE OF THE MIDDLE
OF THE VEIN. THE CLAIM IS 96 FEET WIDE AND 1500 FEET LONG.
