UNDERSIGNED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN AN/VAN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
