THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 580 S15E FROM NUCRN SE 1/4 S. 17, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SE 1/4, RANGE 53E, S. 17 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
