THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 550 S70 E FROM N1/4 Sec 17, TOWNSHIP 19 N, RANGE 53 E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 OF SE 1/4 Sec 17 T19N R33E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
