SAID CLAIM LIES WITHIN THE NE 1/4 & SE 1/4 SEC. 17 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
