THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1250 N7E FROM SD GRN NE 1/4 Sec. 17, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4 10 UNDERSIGNED CLAIMS 190 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN A/VAN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
