THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 270' S 40' E FROM NE 1/4 Sec. 17, TOWNSHIP 19N, RANGE 53E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4 Sec. 17 OF THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 100' FEET IN AN/EAST DIRECTION, AND, 10 FEET IN N/W DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
