THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 220 S25E FROM NW 1/4 NE 1/4 Sec. 17, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 Sec. 8, NW 1/4 Sec. 17, T19N R53E MDB. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
