SAID CLAIM LIES WITHIN THE SE 1/4 10 19N R53E 10 19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
