SAID CLAIM LIES WITHIN THE N 6 1/4 E 1/4 SECTION, FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN EAST DIRECTION, AND, 300 FEET IN A/VAN West DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
