THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1260 S 2 E FROM N 1/4 NE 1/4 Sec 8, TOWNSHIP 19 N, RANGE 53 E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE ALM 1/4 NE 1/4 Sec. 8 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN N/WAN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
