THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 680' S11E FROM NW CORNER NE 1/4 Sec. 8, T19N R53E, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4, FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1990 FEET IN AN EAST DIRECTION, AND, 10 FEET IN A/N WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
