THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 160' S55E FROM NW CORNER NE 1/4 Sec. 8, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4 Sec. 8, 10' FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
