THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1720 N 1/2 E FROM SW 1/4 SE 1/4 S. 15, TOWNSHIP 19 N, RANGE 53 E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 SE 1/4 Sec 5 T 19 N R 53 E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/AN EAST DIRECTION, AND, 1490 FEET IN A/AN West DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
