THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1690 N 6 W FROM SE CORN SE 1/4 Sec. 6, TOWNSHIP 19 N, RANGE 53 E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 5, SE 1/4 Sec. 6 T19N R53E NDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN N/W DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
