SAID CLAIM LIES WITHIN THE SW 1/4 Sec. 5, UNDERMINED CLAIMS 1490 FEET IN AN/EAST DIRECTION, AND, 1810 FEET IN AN/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
