THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 530' N20W FROM SE 1/4 Sec 6, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 Sec 5, 5 1/4 Sec 6, T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1190 FEET IN AN/EAST DIRECTION, AND, 1010 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.

THERE ARE 7 POSTS AT LEAST 3 INCHES IN DIAMETER BY 4-1/2 FEET LONG SET 1 FOOT IN THE GROUND, ONE FOR THE DISCOVERY MONUMENT, ONE FOR EACH OF THE FOUR CORNERS AND ONE AT THE CENTER OF EACH SIDE LINE AS PRESCRIBED BY MRS. 517.030.
