THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 220' S60°W FROM NE GRN NE 1/4 Sec. 7, TOWNSHIP 19N, RANGE 53E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 8, NE 1/4 Sec. 7 UNDESIGNED CLAIMS 11478 FEET IN AN/EAST DIRECTION, AND, 10 FEET IN AN/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
