THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 760' N 15' W FROM SE CORN NE 1/4 Sec 7, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 8, NE 1/4 Sec. 7 T19N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1499 FEET IN AN/EAST DIRECTION, AND, 1010 FEET IN AN/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
