THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 240' N50W, RANGE 53E, TOWNSHIP 19N, FROM SE 1/4 NE 1/4 Sec 7, T19N R59E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 SW 1/4 Sec 8, UNDERSIGNED CLAIMS ~~1490~~ FEET IN AN/EAST DIRECTION, AND, 10 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
