THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 300' N 33W FROM SE 1/4 NE 1/4 Sec. 7, TOWNSHIP 19N, RANGE 53E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SE 1/4 NE 1/4 FROM THIS DISCOVERY MONUMENT, THE UNDERIGNED CLAIMS TO FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
