THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1000' N 15° W FROM SE CORN SE 1/4 Sec. 7, TOWNSHIP 19N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SE 1/4 FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 1490 FEET IN A/N/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
