THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1240 580' FROM NW CORN NW 1/4 Sec. 17, TOWNSHIP 19N, RANGE 53E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 17 AND NE 1/4 Sec. 18 UNDERSIGNED CLAIMS 10 FEET IN AN/EAST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
