LODE MINING CLAIM
NOTICE AND CERTIFICATE OF LOCATION

Notice is hereby given that the undersigned hereby located and claimed on behalf of the locator herein described a lode mining claim on unsurveyed, public lands in the Mineral Hill Mining District, Eureka County, Nevada.

- (a) The name of the claim is WHY # 80.
- (b) The name and address of the locator is:

- (c) The date of location is August 16, 1990.
- (d) The locator claims 20 linear feet in an easterly direction and 1480 linear feet in a westerly direction along the course of the vein each way from the point of discovery, which point is marked by a durable plastic pipe at least three inches in diameter and four feet in length set in the ground. The width of the claim is 300 feet on each side from the point of discovery along the entire length of the claim.
- (e) Location work consisted of making the map(s) as provided for in NRS 517.040.
- (f) This claim is marked at each corner and at each side center by a durable plastic pipe at least three inches in diameter by four feet in length set in the ground and bearing markings illustrating it as the respective corner of the claim. The point of discovery is located in the SE 1/4 of Section 22, T. 26 N., R. 52 E., M.D.B. & M., approximately 1550 feet North and 520 feet West from the NW corner of Section 26, T. 26 N., R. 52 E., M.D.B. & M. The Northwest corner of this claim is located approximately 1480 feet Westerly and 300 feet Northerly of the Point of Discovery; thence 1500 feet Easterly to the Northeast corner; thence 600 feet Southerly to the Southeast corner; thence 1500 feet Westerly to the Southwest corner; thence 600 feet Northerly to the Northwest corner, the Point of Beginning.

This claim covers, among other things, all dips, variations, spurs, angles and all veins, ledges, and other valuable deposits within the lines of this claim, together with all water and timber and any other rights appurtenant, as allowed by law of the State and/or United States.
