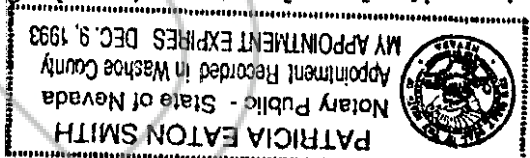

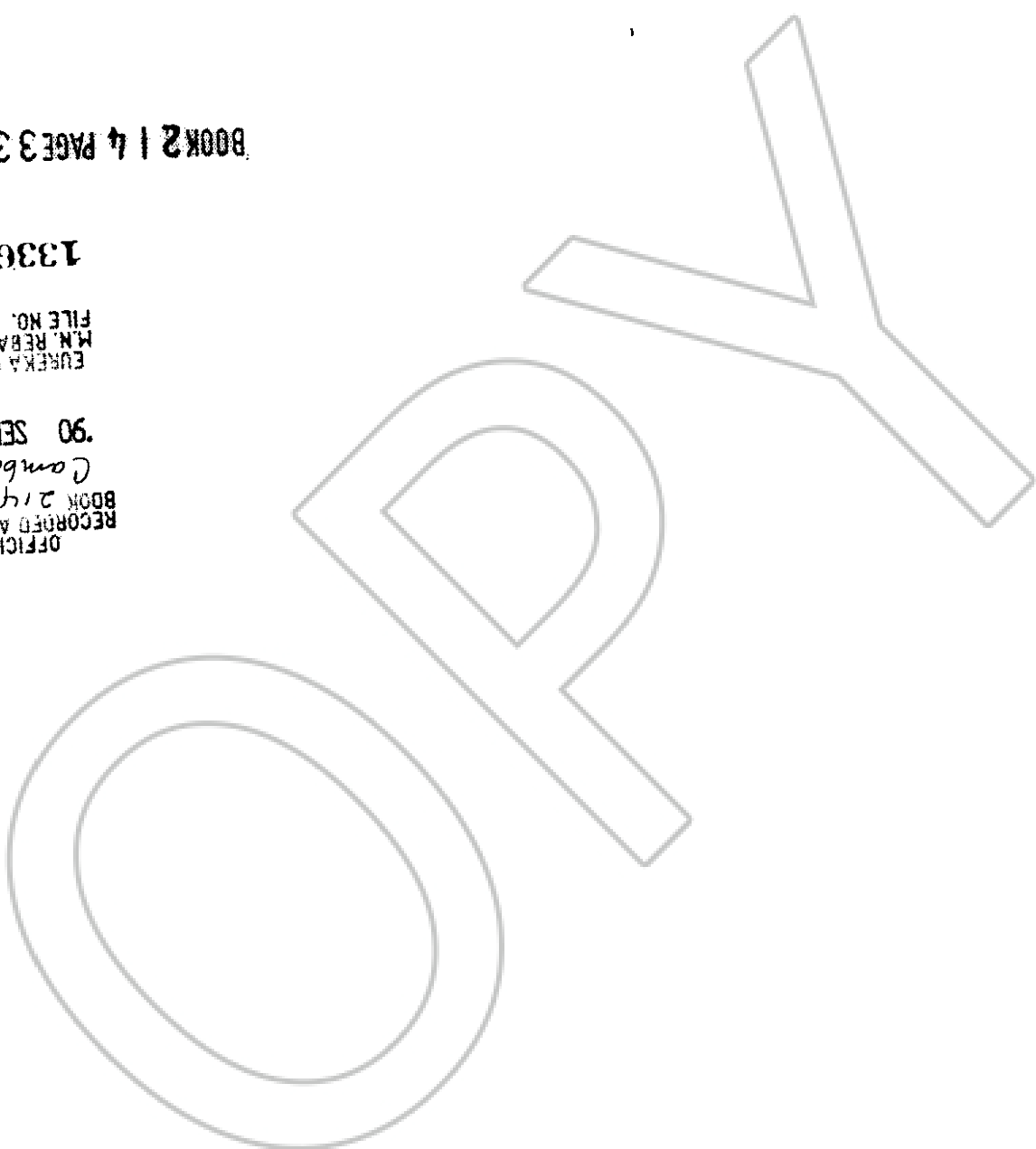

GEOLOGIC REPORT
