CERTIFICATE OF LOCATION

LODE MINING CLAIM

The undersigned citizen of the United States, as agent for John Prochman, 127 Cheney Street, Reno, Nevada, 89501, hereby certifies and declares as follows, to wit:

That on the 1 day of Sept., 1999 the above lode mining claim was duly located in the unknown Mining District, Eureka County, Nevada.

The locator hereby claims 1475 feet in a South direction and 25 feet in a North direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is North-South.
