That on the 26 day of July, 1993 the above lode mining claim was duly located in the unknown Mining District, Eureka County, Nevada.

The locator hereby claims 1975 feet in a South direction and 25 feet in a North direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is North-South.
