The undersigned citizen of the United States, as agent for John Prochnau, 127 Cheney Street, Reno, Nevada, 89501, hereby certifies and declares as follows, to wit:

That on the 26 day of July, 1999 the above lode mining claim was duly located in the unknown Mining District, Eureka County, Nevada.

The locator hereby claims 1925 feet in a South direction and 25 feet in a North direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is North-South.

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 4250 feet in a S20°E direction from the surveyed common corner of sections 8, 9, 17, 18, 19, 20, 36, 37, 38, 39, 40

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
