That on the 26 day of July, 1999, the above lode mining claim was duly located in the unknown Mining District, Eureka County, Nevada.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments.
