NE 1/4 SE 1/4 Sec 32 T20N R33E MDN. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 20 FEET IN AN AN SOUTH DIRECTION, AND, 1480  
FEET IN A AN NORTH DIRECTION, AND, 125 FEET ON EACH SIDE OF THE MIDDLE
