Sec. 32 T20N R53E NM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 20 FEET IN AN/AN SOUTH DIRECTION, AND, 1480  
FEET IN A/AN NORTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
