Sec. 27 T20N R57E MDN. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 1480 FEET IN AN/AN NORTH DIRECTION, AND, 20  
FEET IN AN/AN south DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
