Sec. 27 T20N R53E MDN. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 1480 FEET IN AN/AN North DIRECTION, AND, 20  
FEET IN A/AN South DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
