Sec. 27 T22N R57E MDM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 1480 FEET IN AN SOUTH DIRECTION, AND, 20  
FEET IN AN NORTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
