THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1610 N 20E FROM SW CORN SE 1/4 Sec 27, TOWNSHIP 20N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4 SE 1/4 Sec 27, T20N R51E MDN. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1480 FEET IN AN NORTH DIRECTION, AND, 20 FEET IN AN SOUTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
