SAID CLAIM LIES WITHIN THE NW 1/4, NE 1/4, SW 1/4, SE 1/4 Sec. 27 T20N R57E MM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1480 FEET IN AN/AN NORTH DIRECTION, AND, 20 FEET IN A/AN SOUTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
