SAID CLAIM LIES WITHIN THE NW 1/4 SW 1/4 Sec 27 T28N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 1480 FEET IN AN/AN NORTH DIRECTION, AND, 20 FEET IN A/AN SOUTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
