Sec 27, T23N R33E MDM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 20 FEET IN AN/N NORTH DIRECTION, AND, 1980  
FEET IN AN/S SOUTH DIRECTION, AND, 205 FEET ON EACH SIDE OF THE MIDDLE
