Sec 28 T20N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 20 FEET IN AN/EAST DIRECTION, AND, 1480
FEET IN A/WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
