SE 1/4 Sec. 28, T20N R53E HOM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 20 FEET IN AN AN WEST DIRECTION, AND, 1180  
FEET IN A AN EAST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
